Proposed Green Hill Solar Farm Old and Walgrave - Site A and A.2

You should have received, by post, a flyer from Green Hill Solar showing the proposed Scheme for a 500 megawatt solar farm, making it one of the biggest in the UK. The proposal covers nine sites and Site A straddles Old and Walgrave parishes, with eight parcels of land in Old and 21 in Walgrave, making a total of 429 acres. Site A.2 is 161 acres and is located on the Kettering Road, Walgrave junction to the A43. Both sites together total 590 acres.

In summary, the proposal is for an operational life of 60 years after which it will be decommissioned. During the operational life the solar panels would be replaced once and batteries at the storage facilities replaced twice. The equipment would be arrays of fixed and tracker panels at heights of 4.5 metres (15 feet) at greatest inclination and 2.5 metres (8 feet) when horizontal and sited at 0.4 metres off the ground. It is likely that there will be a need for an electrical substation at either of these sites, along with underground cabling to take the electricity to the National Grid.

As with all developments there are those in favour and those opposed, we would like to solicit your views so that when the time comes to give a response it will be the views of the village.
